**THE SHROPSHIRE COUNTY COUNCIL (FOOTPATH CREATION, PARISH OF
GREAT NESS) PUBLIC PATH CREATION ORDER 2018**

This Order is made by the Shropshire Council (“the Council”) under section 26 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that having regard to the matters set out in section 26(1), there is a need for a public footpath over the land to which this Order relates, and that it is expedient that the path should be created.

This Order is also made under section 53A (2) of the Wildlife and Countryside Act 1981 (“the 1981 Act”) because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53 (3) (a) (iii) of the 1981 Act, namely, the creation (as authorised by this Order) of a new right of way over the land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public footpath.

BY THIS ORDER:

1. There shall be on the date of confirmation of this order a public footpath over the land at Nesscliff Military Training Area in the Parish of Great Ness and described in Part 1 of the Schedule to this order and shown by a bold broken line on the map attached to this order and thereupon the Shropshire definitive map and statement shall be modified accordingly.

2. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 2 of the Schedule.

SCHEDULE

PART I

Description of land

A footpath to be created from point A on the order map (GR SJ 3642 1838) at a junction with Footpaths 33 and 92, Great Ness, running in a general north westerly direction on a natural surface to meet point B on the order map (GR SJ 3620 1851) at a junction with Footpath 85, Great Ness; a total distance of approximately 259 metres with a width of 2 metres throughout.
