- 118/2223 **MINUTES** it was **RESOLVED** to confirm the minutes of the Council Meeting dated 19th January 2023 as being a correct record, subject to amending 111/2223d to state that SC's Enforcement Officer had visited the dog's owners. The chairman was authorised to sign the amended minutes.

119/2223 **REPORTS**

- *a) Police Report* none.
- *b) Shropshire Council* Cllr. Potter reported as follows:
 - The SC budget is now £260 million less than when SC became unitary in 2009.
 - 4.99% Council Tax increase for SC 2023/4.
 - No charges for green waste.
 - The LP Review Stage 1 report states that SC need to find 1,500 homes extra in LP and extra employment land. This is likely to be a strategic site, rather than spread around settlements.
 - Still high demand for housing
 - Boundary Review ongoing for SC areas recommendations due to be published 25th April. Cllr. Potter's constituency may extend into the areas near/within the Severn floodplain.
 - Noted that SC Highways technician, Jonathan Ingoldby, had replied saying a new drain is needed at Milford Bank which would require the co-operation of third party landowners at Perry Cottage. Cllr. Potter offered to liaise with SC highways to ensure this issue is dealt with swiftly.
 - In response to a query re comments on the planning portal re the planning application at Wilcott Water tower site, it was confirmed that Wilcott is still a

community cluster, not Open Countryside, as SAMDEV is the prevailing LP policy.

- *c)* Youth Club Cllr. Gilbert reported that attendee numbers were low in early Feb, due to a group not attending. The numbers are increasing again now.
- *d)* Great Mess to Little Mess Cllr. Diggory reported that the group has £150 in the bank. Litter picks are planned for March, April and May.
- *CIL Working Group* it was <u>RESOLVED</u> to approve the group minutes and recommendations:
 It was agreed to progress the disabled access gate and keep the old metal gate as a replacement for the kissing gate at the BMX track. It was further <u>RESOLVED</u> to delegate to the clerk to add the landscaping works to the asset register, insure the willow classroom
- and new hedging/fencing on the access track.
 f) Nesscliffe Country Park Working Group the clerk informed the council that a meeting is to take place tomorrow. She advised that she had received an email asking about poo bins at the country park. It was agreed to raise this at the WG but noted they would be difficult to empty within the park area. It was further **<u>RESOLVED</u>** to purchase a poo bag dispenser for Nesscliffe and Wilcott playing field, budget up to £100.
 - Actions:
 - WG to report back to council re Nesscliffe Hill
 - <u>Clerk to purchase poo bag dispensers for Nesscliffe and Wiclott play areas, G.</u> <u>Taylor to fit.</u>
- g) Clerk's Report the report was noted. It was <u>RESOLVED</u> to ask G. Taylor to clear Hopton Lane from The Three Pigeons junction to the school, part funded by EMG. Action: Clerk to instruct G Taylor
- *h) Parish Councillor Reports (of external meetings attended)*
 - Warm Welcome Cllr. Brooks said that he has been invited to no further meetings on Warm Welcome and it was agreed to remove this item from the clerk's report.
 - **Nesscliffe VH** Cllr. Gilbert informed the council that the hall has no plans for the King's Coronation.
 - Great Mess to Little Mess Big Help Out Cllr. Dickinson reported that she has registered Great Mess to Little Mess's Big Help Out event, on 8th May, on the King's Coronation events website.

1) 22/05703/FUL - Residential Development Land At Former Water Tower, Wilcot Avenue, Wilcott

Proposal: Residential development of 4no. semi-detached dwellings with associated parking and access work.

<u>Comments: It was **RESOLVED** to support the application and ask that the houses are in keeping with other houses in Wilcott e.g. rendered finish.</u>

- 23/00622/FUL Crowdy, Great Ness, Shrewsbury, SY4 2LD Proposal: Installation of render and paint with weathershield off white/gardenia to front elevation Comments: It was **RESOLVED** to support the application.
- 23/00785/FUL Nesscliffe Hotel, Holyhead Road, Nesscliffe, Shrewsbury, SY4 1DB Proposal: Change of use of hotel to a dwelling to include creation of private amenity space (re-submission) Comments: It was **RESOLVED** to support the application.
- 4) Pre-app enquiry re former Wilcott Speedcast satellite site (see emailed documents), ref PREAPP23/00097

<u>Comments</u>: It was **RESOLVED** to comment that the "Proposed Change of Use to Class E (g)(ii) Research and development of products or processes; and Class E (g)(iii) Industrial processes; and the associated use of the land for the storage of lock up containers for secure Storage", is potentially acceptable. From reading the Planning Statement, the parish council recognises that other uses may be a possibility. The parish council would want the following factors to be considered in relation to any future uses: hours of operation (daytime hours preferred), impact on landscape including light pollution, impact on volume of traffic and highway safety (in particular, uses that will result in more HGVs passing through the villages are not supported), noise levels. Residential is not supported at the site, including a paragraph 80 dwelling.

122/2223 PARISH MATTERS

 - Felton Butler the first 100 yards of road past Pryce's Farm are in good condition but after that there are excessive potholes.
 - Highways England gorse at Wolfshead they confirmed they would look into this urgently

- *EMG works* Cllr. Diggory reported that he is in the process of doing a pavement survey which will inform the 2023/4 EMG grant application.
 <u>Action: Cllr. Diggory to complete pavement survey and clerk to draft EMG application, for approval at council meeting on 4th April.</u>
- *e) King's Coronation* proposal to purchase time capsule and medals for school children it was **<u>RESOLVED</u>** to commemorate the event with the following:
 - Purchase a 50p with the King's head for all children in the parish.
 - Have a parish photo outside The Three Pigeons with drone overhead photo of the parish.
 - The Annual Parish Meeting to celebrate the King's Coronation.
 - Work with the school to lay a time capsule on the community land.

1) *Policing charter priorities* – it was **RESOLVED** to sign the police charter and name the following priorities, in descending order: ASB including substance misuse, criminal damage, speeding.

Action: Clerk to submit charter contract to the police.

 Request for funding assistance with defib training from Little Ness VH – it was <u>RESOLVED</u> to invite the 4 interested people to the WI First Aid training event, on 16th March. If a larger group comes forward, the parish council may consider contributing towards a separate event.

- 3) Car park, Stonehouse Close it was noted that the housing association had sought permission to excavate part of the car park to repair the wall. It was agreed to allow this, subject to insurance being in place, the car park being re-instated to its condition prior to the accident, and a preference for work to be done outside of term time. It was noted that a date for the work is not known yet.

127/2223 PATH AT NESSCLIFFE PLAYING FIELD ACCESS TRACK AND DISABLED ACCESS GATE

- (i) It was <u>RESOLVED</u> to procure a disabled access gate at the main entrance to the play area. The quote of £2,021 plus VAT from Ray Parry Playgrounds includes necessary alterations to the fencing width.
